

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Sif Oidak District Cenpatico Award Budget)**

**RESOLUTION NO. 18-234**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, by Sif Oidak District Council Resolution No. SODC-18-096, the Sif Oidak District**  
13 **has authorized and submitted for review and approval the Sif Oidak District**  
14 **Cenpatico Award Budget, which is incorporated by this reference, in the amount**  
15 **of \$21,997.81, \$16,997.81 of which to be funded by the Cenpatico Award and**  
16 **\$5,000.00 of which to be funded by Sif Oidak District mining royalties; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed the Sif Oidak District Cenpatico**  
18 **Award Budget and recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **Sif Oidak District Cenpatico Award Budget in the amount of \$21,997.81, \$16,997.81**  
21 **of which to be funded by the Cenpatico Award and \$5,000.00 of which to be funded**  
22 **by Sif Oidak District mining royalties.**


23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Sif Oidak District**  
24 **Cenpatico Award Budget shall be managed and expended in accordance with**  
25 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**  
26 **Nation's laws, provided that any amendments or modifications shall be**  
27 **authorized under District Council resolution and submitted for prior approval by**  
28 **the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
30 **day of JULY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
35 **(48 Stat.984).**


