

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Division of
Behavioral Health Tas Tonlik Ki Program Budget Amendment No. 2)**

RESOLUTION NO. 18-245

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Health and Human Services Division of Behavioral
8 Health Tas Tonlik Ki Program Budget in the amount of \$1,250,438.00 was
9 approved by Resolution No. 17-447; and

10 **WHEREAS,** the FY 2018 Department of Health and Human Services Division of Behavioral
11 Health Tas Tonlik Ki Program Budget Amendment No. 1 was approved by
12 Resolution No. 18-067 in the amount of \$1,250,438.00; and

13 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
14 review and approval its FY 2018 Division of Behavioral Health Tas Tonlik Ki
15 Program Budget Amendment No. 2, which is incorporated by this reference, and
16 which adjusts personnel and/or operational line items; and

17 **WHEREAS,** the FY 2018 Department of Health and Human Services Division of Behavioral
18 Health Tas Tonlik Ki Program Budget Amendment No. 2 will increase the FY 2018
19 Department of Health and Human Services Division of Behavioral Health Tas
20 Tonlik Ki Program Budget by \$484,576.00 from \$1,250,438.00 to \$1,735,014.00; and

21 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
22 reviewed the FY 2018 Department of Health and Human Services Division of
23 Behavioral Health Tas Tonlik Ki Program Budget Amendment No. 2 and
24 recommend its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 **FY 2018 Department of Health and Human Services Division of Behavioral Health**
27 **Tas Tonlik Ki Program Budget Amendment No. 2 effective October 1, 2017 for an**
28 **increase of \$484,576.00 from \$1,250,438.00 to \$1,735,014.00 which shall be funded**
29 **by program revenues.**

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
31 **Nation chairperson or any designated official is authorized to administer and**
32 **expend the FY 2018 Department of Health and Human Services Division of**
33 **Behavioral Health Tas Tonlik Ki Program Budget Amendment No. 2, provided that**

Tohono O'odham Legislative Council.


The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH

Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat.984).
