

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Judicial Branch Budget Amendment No. 2)

RESOLUTION NO. 18-246

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Judicial Branch Budget in the amount of \$6,974,438.74 was approved**
8 **by Resolution No. 17-435, as amended by Resolution No. 17-602, which increased**
9 **the FY 2018 Judicial Branch Budget to \$6,977,096.38; and**

10 **WHEREAS, pursuant to 6 Tohono O'odham Code Chapter 1, Section 1209(B), court fees**
11 **collected by the Judicial Court and transmitted "to the Nation's treasurer for**
12 **deposit in a separate fund account . . . may be expended by the Judicial Court in**
13 **accordance with a budget approved by the Legislative Council"; and**

14 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
15 **2018 Budget Amendment No. 2, which is incorporated by this reference and which**
16 **will adjust operational and/or personnel line items; and**

17 **WHEREAS, the FY 2018 Judicial Branch Budget Amendment No. 2 will increase the total**
18 **budget amount by \$24,861.61 from \$6,977,096.38 to \$7,001,957.99; and**

19 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2018**
20 **Judicial Branch Budget Amendment No. 2 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2018 Judicial Branch Budget Amendment No. 2 effective October 1, 2017, which**
23 **includes a \$24,861.61 increase from \$6,977,096.38 to \$7,001,957.99 that shall be**
24 **funded by the Judicial Administrative Fees account.**


25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge or any**
26 **designated official is authorized to administer and expend the FY 2018 Judicial**
27 **Branch Budget as amended, provided that any amendments or modifications**
28 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
30 **day of JULY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**




