

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 San Lucy District Maintenance Department Budget Amendment
No. 1, FY 2018 San Lucy District Council Budget Amendment No. 1, and FY 2018 San
Lucy District Administration Department Budget Amendment No. 1)**

RESOLUTION NO. 18-252

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2018 San Lucy District Budget in the amount of \$5,501,614.20 was
13 authorized by San Lucy District Council Resolution No. SL 10-197-17 and approved
14 by Legislative Council Resolution No. 17-546; and

15 **WHEREAS,** by San Lucy District Council Resolution No. SL 05-83-18, the San Lucy District has
16 authorized and submitted for review and approval its FY 2018 Maintenance
17 Department Budget Amendment No. 1, which is incorporated by this reference
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** by San Lucy District Council Resolution No. SL 07-132-18, the San Lucy District has
20 authorized and submitted for review and approval its FY 2018 Council Budget
21 Amendment No. 1, which is incorporated by this reference and which will adjust
22 operational and/or personnel line items; and

23 **WHEREAS,** by San Lucy District Council Resolution No. SL 05-82-18, the San Lucy District has
24 authorized and submitted for review and approval its FY 2018 Administration
25 Department Budget Amendment No. 1, which is incorporated by this reference
26 and which will adjust operational and/or personnel line items; and

27 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 San Lucy District
28 Maintenance Department Budget Amendment No. 1, FY 2018 San Lucy District
29 Council Budget Amendment No. 1, and FY 2018 San Lucy District Administration
30 Department Budget Amendment No. 1 and recommends its approval.



6 **District Maintenance Department Budget, FY 2018 San Lucy District Council**
7 **Budget Amendment No. 1, and FY 2018 San Lucy District Administration**
8 **Department Budget Amendment No. 1 as amended shall be managed and**
9 **expended in accordance with Article IX, Section 7 of the Constitution of the**
10 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
11 **modifications shall be authorized under District Council resolution and**
12 **submitted for prior approval by the Tohono O'odham Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13th**
14 **day of JULY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
16 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
17 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
19 **(48 Stat.984).**




