

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the Professional Services Contract between the
Tohono O'odham Nation and Anthony Payson II, Esq.)**

RESOLUTION NO. 18-267

1 WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power "to employ legal counsel for the protection and advancement of the
3 Tohono O'odham Nation ..." (Constitution, Article VI, Section 2(a)); and

4 WHEREAS, the increasing needs of tribal members for legal representation in criminal
5 matters has caused a need for attorneys to handle cases where the Tohono
6 O'odham Advocate Program is ethically conflicted out of the representation; and

7 WHEREAS, the Nation approved a Professional Service Contract with Anthony Payson II, Esq.
8 by Resolution No. 17-535; and


9 WHEREAS, the Tohono O'odham Advocate Program has prepared and submitted for review
10 an Amendment No. 1 to the Professional Services Contract with Anthony Payson
11 II, Esq.; and

12 WHEREAS, the Domestic Affairs Committee has reviewed the Amendment No. 1 and
13 recommends its approval.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
15 Amendment No. 1 to the Professional Services Contract between the Tohono
16 O'odham Nation and Anthony Payson II, Esq., in substantially the form attached
17 hereto and authorizes the Chairman to execute it.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND
19 day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0-
20 AGAINST; -0- NOT VOTING; and 232.3[09] ABSENT, pursuant to the powers vested in the Council
21 by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the
22 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat.984).


