

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Enrollment or Adoption Applications for Membership in the Tohono
O'odham Nation for August 2018)

RESOLUTION NO. 18-268

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended, the Enrollment Committee has reviewed and**
7 **recommended approval of the enrollment or adoption applications for the**
8 **individuals identified in the August 2018 Membership Applications List, which is**
9 **incorporated by this reference; and**

10 **WHEREAS, pursuant to Article VIII, Section 1 (C)(1) and (2) of the Enrollment Ordinance:**

11 **The final determination as to whether an application for enrollment or**
12 **adoption is approved or rejected by the Tohono O'odham Council shall**
13 **be reduced to writing and signed by the Chairman of the Tohono**
14 **O'odham Council regarding each application for enrollment or adoption**
15 **filed with the enrollment committee. Such determinations shall set forth**
16 **the following findings of fact.**

17 **(1) If on an application for adoption, the date of applicant's birth and, the**
18 **degree of Papago - Tohono O'odham Indian blood ascribed to the**
19 **applicant.**

20 **(2) If on an application for enrollment, the date of applicant's birth, the**
21 **membership requirement or requirements which the Tohono O'odham**
22 **Council found the applicant did or failed to establish.**

23 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council has**
24 **reviewed the Enrollment Committee's recommendations and approves the**
25 **applications for enrollment or adoption that are identified in the August 2018**
26 **Membership Applications List which includes the name, date of birth, enrollment**
27 **number, and membership requirement or, for adoption, the degree of Papago-**
28 **Tohono O'odham Indian blood for each applicant.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
30 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
32 **Article II, Section 1(a) or (b) and Section 2 and Article VI, Section 1(h) of the Constitution of the**
33 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
34 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
35 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
