

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of Quarles & Brady, LLP)**

RESOLUTION NO. 18-275

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "employ legal counsel for the protection and advancement of the**
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of Quarles**
6 **& Brady, LLP to represent the Tohono O'odham Nation in matters relating to the**
7 **Cyprus Tohono Corporation Mine; and**

8 **WHEREAS, the Attorney General has recommended an attorney contract with Quarles &**
9 **Brady, LLP for FY 2018, for the period from August 1, 2018 to September 30, 2020**
10 **to be funded by the FY 2018 Office of Attorney General operating budget; and**

11 **WHEREAS, the Domestic Affairs Committee has reviewed the FY 2018 Attorney Contract with**
12 **the law firm of Quarles & Brady, LLP and recommends its approval by the**
13 **Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **Attorney Contract with the law firm of Quarles & Brady, LLP, and authorizes the**
16 **chairperson of the Tohono O'odham Nation to execute it in substantially the form**
17 **attached hereto, provided that if the Nation fails to appropriate or authorize the**
18 **expenditure of sufficient funds to provide for payments under this contract, this**
19 **contract shall terminate on the date such funds are no longer available without**
20 **any termination charges or other liability incurred by the Nation.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
22 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 2,605.3 FOR; 479.3**
23 **AGAINST; [01] NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat.984).**
