

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Division of
Behavioral Health Budget Amendment No. 1)**

RESOLUTION NO. 18-281

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Health and Human Services Division of Behavioral**
8 **Health Budget in the amount of \$3,131,664.00 was approved by Resolution No. 17-**
9 **439; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2018 Division of Behavioral Health Budget**
12 **Amendment No. 1, which is incorporated by this reference, and which adjusts**
13 **personnel and/or operational line items; and**

14 **WHEREAS, the FY 2018 Department of Health and Human Services Division of Behavioral**
15 **Health Budget Amendment No. 1 will increase the FY 2018 Division of Behavioral**
16 **Health Budget by \$113,045.00 from \$3,131,664.00 to \$3,244,709.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2018 Department of Health and Human Services Division of**
19 **Behavioral Health Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2018 Department of Health and Human Services Division of Behavioral Health**
22 **Budget Amendment No. 1 effective October 1, 2017, which includes a \$113,045.00**
23 **increase from \$3,131,664.00 to \$3,244,709.00 that shall be funded by carry forward**
24 **funds from the Self-Governance Funding Agreement.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2018 Department of Health and Human Services Division of**
28 **Behavioral Health Budget as amended, provided that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**
