

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Department of Health and Human Services U.S. Department of**  
**Agriculture Food Distribution Program Budget Amendment No. 1)**

**RESOLUTION NO. 18-282**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Health and Human Services U.S. Department of  
8 Agriculture ("USDA") Food Distribution Program Budget in the amount of  
9 \$232,209.55 was approved by Resolution No. 17-445; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
11 review and approval its FY 2018 USDA Food Distribution Program Budget  
12 Amendment No. 1, which is incorporated by this reference and which will adjust  
13 operational and/or personnel line items; and

14 **WHEREAS,** the FY 2018 Department of Health and Human Services USDA Food Distribution  
15 Program Budget Amendment No. 1 will increase the FY 2018 Budget by \$77,540.45  
16 from \$232,209.55 to \$309,750.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
18 reviewed the FY 2018 Department of Health and Human Services USDA Food  
19 Distribution Program Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 FY 2018 Department of Health and Human Services USDA Food Distribution  
22 Program Budget Amendment No. 1, which includes a \$77,540.45 increase from  
23 \$232,209.55 to \$309,750.00 that shall be funded by the Nation's general fund  
24 pending reimbursement by the grantor, United States Department of  
25 Agriculture.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
27 Nation chairperson or any designated official is authorized to administer and  
28 expend the FY 2018 Department of Health and Human Services USDA Food  
29 Distribution Program Budget as amended, provided that any amendments or  
30 modifications shall be submitted for prior approval by the Tohono O'odham  
31 Legislative Council.



6 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
7 **18, 1934 (48 Stat.984).**


