

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2018 Department of Health and Human Services Division of
Child Welfare Title IV-B Subparts 1 and 2 Carry Forward Budgets)

RESOLUTION NO. 18-292

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services Division of Child Welfare Title IV-
8 B Subpart 1 and Subpart 2 Budgets for the grant period beginning October 1, 2017
9 were approved by Resolution No. 17-441; and

10 **WHEREAS,** the Department of Health and Human Services Division of Child Welfare has
11 prepared and submitted for review and approval its FY 2018 Title IV-B Subpart 1
12 Carry Forward Budget to be funded with \$15,940.77 in carry forward funds from
13 the Stephanie Tubb Jones Child Welfare Services Program and FY 2018 Title IV-B
14 Subpart 2 Carry Forward Budget to be funded with \$20,634.69 in carry forward
15 funds from the Promoting Safe and Stable Families, which are incorporated by
16 this reference; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2018 Department of Human Services, Division of Child Welfare
19 Title IV-B Subpart 1 and Subpart 2 Carry Forward Budgets and recommend their
20 approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 **FY 2018 Department of Health and Human Services Division of Child Welfare Title**
23 **IV-B Subpart 1 Carry Forward Budget in the amount of \$15,940.77, effective**
24 **October 1, 2017, that shall be funded by the Stephanie Tubb Jones Child Welfare**
25 **Services Program and Title IV-B Subpart 2 Carry Forward Budget in the amount**
26 **of \$20,634.69, effective October 1, 2017, that shall be funded by the Promoting Safe**
27 **and Stable Families.**

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer and
30 expend the FY 2018 Department of Health and Human Services, Division of Child
31 Welfare Title IV-B Subparts 1 and 2 Carry Forward Budgets, provided that any
32 amendments or modifications shall be submitted for prior approval by the
33 Tohono O'odham Legislative Council.
