

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 General Support Services Human Resources Budget Amendment No. 2)

RESOLUTION NO. 18-294

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1 (d)(2)); and

7 **WHEREAS,** the FY 2018 General Support Services ("GSS") Human Resources Budget in the
8 amount of \$2,732,912.38 was approved by Resolution No. 17-437, and amended by
9 Resolution No. 18-059 in the amount of \$2,834,912.38; and

10 **WHEREAS,** the GSS has prepared and submitted for review and approval its FY2018 Human
11 Resources Budget Amendment No. 2, which is incorporated by this reference and
12 which will adjust operational and/or personnel line items; and

13 **WHEREAS,** the FY 2018 GSS Human Resources Budget Amendment No. 2 will not change the
14 overall total budget amount; and

15 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
16 reviewed the FY 2018 GSS Human Resources Budget Amendment No. 2 and
17 recommends its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2018 General Support Services Human Resources Budget Amendment No. 2
20 effective October 1, 2017, which will not change the overall total budget amount
21 of \$2,834,912.38.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation Chairperson or any designated official is authorized to administer and
24 expend the FY 2018 General Support Services Human Resources Budget as
25 amended, provided however, that any amendments or modifications shall be
26 submitted for prior approval by the Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
28 day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
29 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
30 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
31 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
33 18, 1934 (48 Stat.984).
