

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Revenue Projection of the Tohono O'odham Nation)**

RESOLUTION NO. 18-296

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power "to manage any
2 funds within the exclusive control of the Tohono O'odham Nation" (Constitution
3 of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and

4 **WHEREAS,** the Nation's Treasurer has calculated that \$101,906,344.00 is the projected
5 amount needed to fund the Nation's FY 2019 General Fund Budgets for the
6 Executive, Legislative and Judicial Branches; and


7 **WHEREAS,** the Budget and Finance Committee and the Executive Office have reviewed the
8 FY 2019 Revenue Projection, which is incorporated by this reference; and

9 **WHEREAS,** the Budget and Finance Committee and the Executive Office recommend the
10 adoption of the FY 2019 Revenue Projection in the amount of \$101,906,344.00 to
11 fund the FY 2019 General Fund Budgets.

12 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that it approves
13 the FY 2019 Revenue Projection in the amount of \$101,906,344.00 for the purpose
14 of funding the Nation's FY 2019 General Fund Budgets.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
16 day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
17 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
18 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
19 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21 18, 1934 (48 Stat.984).
