

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Tohono O'odham Nation Judicial Branch Budget)**

**RESOLUTION NO. 18-297**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any**  
2 **funds within the exclusive control of the Tohono O'odham Nation... and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Judicial Branch has prepared and submitted for**  
8 **review and approval its FY 2019 Tohono O'odham Nation Judicial Branch Budget,**  
9 **which is incorporated by this reference, in the amount of \$7,131,686.87 to be**  
10 **funded from the Nation's general fund; and**

11 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2019**  
12 **Tohono O'odham Nation Judicial Branch Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
14 **FY 2019 Tohono O'odham Nation Judicial Branch Budget effective October 1, 2018**  
15 **in the amount of \$7,131,686.87, which shall be funded by the Nation's general**  
16 **fund.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge or any**  
18 **designated official is authorized to administer and expend the FY 2019 Tohono**  
19 **O'odham Nation Judicial Branch Budget, provided that any amendments or**  
20 **modifications shall be submitted for prior approval by the Tohono O'odham**  
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
23 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat.984).**
