

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Hewel Ni'ok KOHN Corporation for Public Broadcasting  
Community Service Grant Unrestricted Budget)**

**RESOLUTION NO. 18-302**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2019**  
8 **Hewel Ni'ok KOHN Corporation for Public Broadcasting ("CPB") Community**  
9 **Service Grant ("CSG") Unrestricted Budget in the amount of \$213,434.68, which is**  
10 **incorporated by this reference, and which shall be funded by the Nation's general**  
11 **fund pending reimbursement by the grantor; and**

12 **WHEREAS, CPB CSG funding is restricted to operational support of KOHN's radio broadcast**  
13 **operations and does not provide for administrative cost rates normally applied**  
14 **to grants as indirect costs, making it necessary for the established indirect cost**  
15 **rate of the Nation to be waived for this grant; and**

16 **WHEREAS, CPB permits the Nation to record and report the total calculated administrative**  
17 **support costs provided to Hewel Ni'ok as additional non-federal financial**  
18 **support; and**

19 **WHEREAS, as each CPB CSG award has an expenditure period of two years, the 2019 grant**  
20 **award will have a grant period of October 1, 2018 through September 30, 2020; and**

21 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**  
22 **FY 2019 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
23 **Service Grant Unrestricted Budget and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
25 **FY 2019 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
26 **Service Grant Unrestricted Budget effective October 1, 2018 in the amount of**  
27 **\$213,434.68, which shall be funded by the Nation's general fund pending**  
28 **reimbursement by the grantor.**

29 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the waiver of**  
30 **the indirect cost rate as required by the grant, provided that the Nation shall**  
31 **record and report the indirect administrative support costs provided to Hewel**  
32 **Ni'ok as additional non-federal financial support.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
