

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Child Care and Development Fund
Discretionary Budget and FY 2019 Department of Education Child Care and
Development Fund Mandatory Budget)

RESOLUTION NO. 18-309

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and
8 approval its FY 2019 Child Care and Development Fund Discretionary Budget,
9 which is incorporated by this reference, in the amount of \$678,073.00 and its FY
10 2019 Child Care and Development Fund Mandatory Budget, which is
11 incorporated by this reference, in the amount of \$590,445.00, both totaling
12 \$1,268,518.00, to be funded by the Nation's general fund pending reimbursement
13 by grantor, the United States Department of Health and Human Services; and

14 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
15 reviewed the FY 2019 Department of Education Child Care and Development Fund
16 Discretionary Budget and the FY 2019 Department of Education Child Care and
17 Development Fund Mandatory Budget and recommend their approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 **FY 2019 Department of Education Child Care and Development Fund**
20 **Discretionary Budget in the amount of \$678,073.00 and the FY 2019 Department**
21 **of Education Child Care and Development Fund Mandatory Budget in the amount**
22 **of \$590,445.00, effective October 1, 2018, with a total amount of \$1,268,518.00,**
23 **which shall be funded by the Nation's general fund pending reimbursement by**
24 **the grantor, the United States Department of Health and Human Services.**

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
26 Nation chairperson or any designated official is authorized to administer and
27 expend the FY 2019 Department of Education Child Care and Development Fund
28 Discretionary Budget and the FY 2019 Department of Education Child Care and
29 Development Fund Mandatory Budget, provided that any amendments or
30 modifications shall be submitted for prior approval by the Tohono O'odham
31 Legislative Council.




