

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Division of Early Childhood
Development Head Start Budgets)

RESOLUTION NO. 18-310

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2019 Division of Early Childhood Development Head Start**
9 **Budgets, which are incorporated by this reference, in the cumulative amount of**
10 **\$1,856,878.00 to be funded by federal funds; and**


11 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
12 **reviewed the FY 2019 Department of Education Division of Early Childhood**
13 **Development Head Start Budgets and recommend their approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2019 Department of Education Division of Early Childhood Development Head**
16 **Start Budgets effective November 1, 2018 in the cumulative amount of**
17 **\$1,856,878.00, which shall be funded by federal funds.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2019 Department of Education Division of Early Childhood**
21 **Development Head Start Budgets, provided that any amendments or**
22 **modifications shall be submitted for prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
25 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat.984).**




