

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Division of Early Childhood
Development Child and Adult Care Food Program Budget)

RESOLUTION NO. 18-311

1 **WHEREAS,** **the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS,** **the Department of Education has prepared and submitted for review and**
8 **approval its FY 2019 Division of Early Childhood Development Child and Adult**
9 **Care Food Program Budget, which is incorporated by this reference, in the**
10 **amount of \$96,485.00, to be funded from the Nation's general fund while the**
11 **Department of Education seeks reimbursement from the State of Arizona's**
12 **Department of Education; and**

13 **WHEREAS,** **the Tohono O'odham Nation has historically sought reimbursement through a**
14 **Child and Adult Care Food Program Service Agreement with the State of Arizona's**
15 **Department of Education; and**

16 **WHEREAS,** **the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2019 Department of Education Division of Early Childhood**
18 **Development Child and Adult Care Food Program Budget and recommend its**
19 **approval.**

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 **FY 2019 Department of Education Division of Early Childhood Development Child**
22 **and Adult Care Food Program Budget, in the amount of \$96,485.00, which shall be**
23 **funded by the Nation's general fund while the Department of Education seeks**
24 **reimbursement from the State of Arizona's Department of Education.**

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2019 Department of Education Division of Early Childhood**
28 **Development Child and Adult Care Food Program Budget, provided that any**
29 **amendments or modifications shall be submitted for prior approval by the**
30 **Tohono O'odham Legislative Council.**



6 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
7 Act of June 18, 1934 (48 Stat.984).






