

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Natural Resources Rodeo and Fair Budget)**

RESOLUTION NO. 18-318

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
8 **approval its FY 2019 Rodeo and Fair Budget, which is incorporated by this**
9 **reference, in the amount of \$317,541.66, of which \$212,541.66 is to be funded from**
10 **the Nation's general fund, and \$105,000.00 is to be funded from Sponsorships,**
11 **Contributions and Program Revenue; and**

12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
13 **have reviewed the FY 2019 Department of Natural Resources Rodeo and Fair**
14 **Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2019 Department of Natural Resources Rodeo and Fair Budget effective**
17 **October 1, 2018 in the amount of \$105,000.00, which shall be funded from the**
18 **Nation's Sponsorships, Contributions and Program Revenue.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation chairperson or any designated official is authorized to administer and**
21 **expend the FY 2019 Department of Natural Resources Rodeo and Fair Budget,**
22 **provided that any amendments or modifications shall be submitted for prior**
23 **approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
25 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 2,848.8 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 235.8 [03] ABSENT, pursuant to the powers vested in the Council**
27 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**
