

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Department of Public Safety Environmental Protection  
Office General Assistance Program Project Budget)**

**RESOLUTION NO. 18-319**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and  
8 approval its FY 2019 Environmental Protection Office General Assistance  
9 Program Project Budget, which is incorporated by this reference, in the amount  
10 of \$685,052.00 to be funded from the Indian General Assistance Program of the  
11 U.S. Environmental Protection Agency; and

12 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
13 2019 Department of Public Safety Environmental Protection Office General  
14 Assistance Program Project Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2019 Department of Public Safety Environmental Protection Office General  
17 Assistance Program Project Budget effective October 1, 2018 in the amount of  
18 \$685,052.00, which shall be funded by the Indian General Assistance Program of  
19 the U.S. Environmental Protection Agency.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2019 Department of Public Safety Environmental Protection Office  
23 General Assistance Program Project Budget, provided that any amendments or  
24 modifications shall be submitted for prior approval by the Tohono O'odham  
25 Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
27 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**






