

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness
Program Budget)**

RESOLUTION NO. 18-323

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the U.S. Department of Justice, Office for Victims of Crime awarded the Tohono
8 O'odham Nation Office of the Prosecutor Grant Award No. 2016-VR-GX-K008 in the
9 amount of \$450,000.00 for a three-year period beginning October 1, 2016 and
10 ending September 30, 2019; and

11 **WHEREAS,** Grant Award No. 2016-VR-GX-K008 was accepted by Resolution No. 17-136; and

12 **WHEREAS,** the Office of the Prosecutor has prepared and submitted for review and approval
13 its FY 2019 Tohono O'odham Victim Witness Program Budget, which is
14 incorporated by this reference, in the amount of \$210,014.94 that shall be funded
15 by the Nation's General Fund pending reimbursement by the grantor; and

16 **WHEREAS,** the FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program
17 Budget does not include Indirect Cost ("IDC") as the agency will not allow IDC to
18 be charged without a current year IDC agreement; and

19 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
20 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program Budget
21 and recommend its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program
24 Budget, in the amount of \$210,014.94 that shall be funded by the Nation's general
25 fund pending reimbursement by the grantor.

26 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council waives the IDC for the
27 FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program
28 Budget.

29 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council authorizes the Tohono
30 O'odham Nation chairperson or any designated official to seek reimbursement
31 or recoup any IDC expense in the event an IDC rate is subsequently approved by
32 the Interior Business Center.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
34 Nation chairperson or any designated official is authorized to administer and
35 expend the FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness




