

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Child Welfare Title IV-B Subparts 1 and 2 Budgets)

RESOLUTION NO. 18-325

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Child Welfare has**
8 **prepared and submitted for review and approval its FY 2019 Title IV-B Subpart 1**
9 **Budget in the amount of \$81,405.21 to be funded by the Stephanie Tubbs Jones**
10 **Child Welfare Services Program and its Subpart 2 Budget in the amount of**
11 **\$197,072.33 to be funded by the Promoting Safe and Stable Families Program,**
12 **which are incorporated by this reference, and cumulatively total \$278,477.54; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2019 Department of Health and Human Services Division of Child**
15 **Welfare Title IV-B Subparts 1 and 2 Budgets and recommend their approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Department of Health and Human Services Division of Child Welfare Title**
18 **IV-B Subpart 1 Budget effective October 1, 2018 in the amount of \$81,405.21,**
19 **which shall be funded by the Stephanie Tubbs Jones Child Welfare Services**
20 **Program, and the Title IV-B Subpart 2 Budget effective October 1, 2018 in the**
21 **amount of \$197,072.33, which shall be funded by the Promoting Safe and Stable**
22 **Families Program.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Health and Human Services Division of Child**
26 **Welfare Title IV-B Subparts 1 and 2 Budgets, provided that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
30 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**


