

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Department of Health and Human Services Division  
of Health Transportation Service Budget Program Revenue Funding)**

**RESOLUTION NO. 18-326**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services ("DHHS") has prepared and  
8 submitted for review and approval its FY 2019 Division of Health Transportation  
9 Service ("HTS") Budget, which is incorporated by this reference, in the amount of  
10 \$3,741,602.00 of which \$2,241,602.00 is to be funded from the Nation's general  
11 fund, and \$1,500,000.00 is to be funded from HTS program revenue; and

12 **WHEREAS,** the portion of the FY 2019 DHHS HTS Budget funded by the Nation's general fund  
13 is addressed by a separate resolution; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
15 reviewed the FY 2019 DHHS HTS Budget program revenue funding and  
16 recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18 FY 2019 DHHS HTS Budget program revenue funding effective October 1, 2018 in  
19 the amount of \$1,500,000.00, which shall be funded by HTS program revenue.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2019 Department of Health and Human Services Division of Health  
23 Transportation Service Budget program revenue funding, provided that any  
24 amendments or modifications shall be submitted for prior approval by the  
25 Tohono O'odham Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
27 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**




