

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2019 Department of Health and Human Services Division  
of Behavioral Health/Indian Health Service Methamphetamine Suicide  
Prevention Initiative Budget)**

**RESOLUTION NO. 18-328**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation received an award notice in the amount of**  
8 **\$176,150.00 for year four of a five-year funding cycle for the budget period of**  
9 **September 30, 2018 through September 29, 2019; and**

10 **WHEREAS, the Department of Health and Human Services Division of Behavioral Health has**  
11 **prepared and submitted for review and approval its FY 2019 Behavioral**  
12 **Health/Indian Health Service Methamphetamine Suicide Prevention Initiative**  
13 **Budget in the amount of \$176,150.00, which is incorporated by this reference,**  
14 **which shall be funded by the Nation's general fund pending reimbursement from**  
15 **the grantor; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
17 **reviewed the FY 2019 Department of Health and Human Services Division of**  
18 **Behavioral Health/Indian Health Service Methamphetamine Suicide Prevention**  
19 **Initiative Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2019 Department of Health and Human Services Division of Behavioral**  
22 **Health/Indian Health Service Methamphetamine Suicide Prevention Initiative**  
23 **Budget effective September 30, 2018 in the amount of \$176,150.00, which shall be**  
24 **funded by the Nation's general fund pending reimbursement from the grantor.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to administer and**  
27 **expend the FY 2019 Department of Health and Human Services Division of**  
28 **Behavioral Health/Indian Health Service Methamphetamine Suicide Prevention**  
29 **Initiative Budget, provided that any amendments or modifications shall be**  
30 **submitted for prior approval by the Tohono O'odham Legislative Council.**
