

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Behavioral Health Substance Abuse Mental Health Services
Administration - Native Connections Grant Budget)

RESOLUTION NO. 18-329

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the Nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation received an award notice in the amount of
8 \$200,000.00 for year three of the five-year funding cycle for the budget period of
9 September 30, 2018 through September 29, 2019, from the Substance Abuse
10 Mental Health Services Administration ("SAMHSA") - Native Connections Grant;
11 and

12 **WHEREAS,** the Department of Health and Human Services Division of Behavioral Health has
13 prepared and submitted for review and approval its FY 2019 Division of
14 Behavioral Health SAMHSA - Native Connections Grant Budget in the amount of
15 \$200,000.00, which is incorporated by this reference and shall be funded by the
16 Nation's general fund pending reimbursement by the grantor; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2019 Department of Health and Human Services Division of
19 Behavioral Health SAMHSA - Native Connections Grant Budget and recommend
20 their approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2019 Department of Health and Human Services Division of Behavioral Health
23 SAMHSA - Native Connections Grant Budget effective September 30, 2018 in the
24 amount of \$200,000.00, which shall be funded by the Nation's general fund
25 pending reimbursement from the grantor.


26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer
28 and expend the FY 2019 Department of Health and Human Services Division of
29 Behavioral Health SAMHSA - Native Connections Grant Budget, provided that any
30 amendments or modifications shall be submitted for prior approval by the
31 Tohono O'odham Legislative Council.
