

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Initiative Administrative Budgets)

RESOLUTION NO. 18-330

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** Initiative IN-01-97 requires that the Nation provides for the annual
8 administrative cost of implementing the provisions of the Initiative; and

9 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
10 2019 Initiative Administrative Budgets, which are incorporated by this reference,
11 in the amount of \$1,761,805.23 to be funded from the Desert Diamond Savings
12 Account; and

13 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Initiative
14 Administrative Budgets and recommends their approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2019 Initiative Administrative Budgets in the amount of \$1,761,805.23 which
17 shall be funded by the Desert Diamond Savings Account.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2019 Initiative Administrative Budgets, provided that any
21 amendments or modifications shall be submitted for prior approval by the
22 Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
24 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**




