

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Department of Health and Human Services DOJ Violence  
Against Women Domestic Violence Grant Budget)**

**RESOLUTION NO. 18-334**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation was awarded the Coordinated Tribal Assistance**  
8 **Solicitation Grant from the Department of Justice ("DOJ"), Award No. 2016-TW-AX-**  
9 **0009, in the amount of \$900,000.00 for a three year grant project period from**  
10 **October 1, 2016 to September 30, 2019 (Resolution No. 17-080); and**

11 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
12 **review and approval its FY 2019 DOJ Violence Against Women Domestic Violence**  
13 **Grant Budget, which is incorporated by this reference, in the amount of**  
14 **\$300,000.00 to be funded by the Nation's general fund pending reimbursement**  
15 **from the grantor; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
17 **reviewed the FY 2019 Department of Health and Human Services DOJ Violence**  
18 **Against Women Domestic Violence Grant Budget and recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2019 Department of Health and Human Services DOJ Violence Against Women**  
21 **Domestic Violence Grant Budget effective October 1, 2018 in the amount of**  
22 **\$300,000.00, which shall be funded by the Nation's general fund pending**  
23 **reimbursement from the grantor.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer**  
26 **and expend the FY 2019 Department of Health and Human Services DOJ Violence**  
27 **Against Women Domestic Violence Grant Budget, provided that any amendments**  
28 **or modifications shall be submitted for prior approval by the Tohono O'odham**  
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
31 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**
