

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Community Health Services Third Party Revenue Budget)**

RESOLUTION NO. 18-335

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") has prepared and**
8 **submitted for review and approval its FY 2019 Division of Community Health**
9 **Services ("CHS") Third Party Revenue Budget, which is incorporated by this**
10 **reference, in the amount of \$40,000.00 to be funded from the State of Arizona**
11 **Health Care Cost Containment Systems ("AHCCCS") collections as well as CPR/AED**
12 **First Aid training fees; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2019 DHHS CHS Third Party Revenue Budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 DHHS CHS Third Party Revenue Budget effective October 1, 2018 in the**
18 **amount of \$40,000.00, which shall be funded by AHCCCS collections and CPR/AED**
19 **First Aid training fees.**

20 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes any**
21 **unexpended CHS third party billing revenue be available for appropriation to the**
22 **CHS in future fiscal years in accordance with a budget approved by Legislative**
23 **Council resolution.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2019 Department of Health and Human Services Division of**
27 **Community Health Services Third Party Revenue Budget, provided that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
31 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**




