

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Food Distribution
Program USDA Food Distribution Budget)**

RESOLUTION NO. 18-336

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services Food Distribution Program has
8 prepared and submitted for review and approval its FY 2019 United States
9 Department of Agriculture ("USDA") Food Distribution Budget which is
10 incorporated by this reference, in the amount of \$231,566.00 to be funded from
11 the Nation's general fund pending reimbursement from the grantor, the USDA;
12 and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2019 Department of Health and Human Services Food
15 Distribution Program USDA Food Distribution Budget and recommend its
16 approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 **FY 2019 Department of Health and Human Services Food Distribution Program**
19 **USDA Food Distribution Budget effective October 1, 2018 in the amount of**
20 **\$231,566.00 which shall be funded by the Nation's general fund pending**
21 **reimbursement from the grantor, the USDA.**

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2019 Department of Health and Human Services Food Distribution**
25 **Program USDA Food Distribution Budget, provided that any amendments or**
26 **modifications shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
29 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
