

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Women, Infants and Children Program Inter Tribal Council of Arizona Grant Budget)

RESOLUTION NO. 18-338

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2019 Women, Infants and Children ("WIC") Program**
9 **Inter Tribal Council of Arizona ("ITCA") Grant Budget, which is incorporated by**
10 **this reference, in the amount of \$160,000.00 to be funded by the Nation's general**
11 **fund pending reimbursement from the grantor, ITCA; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2019 Department of Health and Human Services WIC Program**
14 **ITCA Grant Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2019 Department of Health and Human Services WIC Program ITCA Grant**
17 **Budget effective October 1, 2018 in the amount of \$160,000.00, which shall be**
18 **funded by the Nation's general fund pending reimbursement from the grantor,**
19 **ITCA.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2019 Department of Health and Human Services Women, Infants**
23 **and Children Program Inter Tribal Council of Arizona Grant Budget, provided**
24 **that any amendments or modifications shall be submitted for prior approval by**
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
27 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**


