

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2019 Executive Branch Tribal Budgets)**

**RESOLUTION NO. 18-339**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the Nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY  
8 2019 Executive Branch Tribal Budgets for the period beginning October 1, 2018  
9 and ending on September 30, 2019 which are incorporated in summary by this  
10 reference, in the amount of \$101,902,130.21 to be funded from the General Fund;


12 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Executive Branch  
13 Tribal Budgets and recommend their approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
15 FY 2019 Executive Branch Budgets effective October 1, 2018 in the amount of  
16 \$101,902,130.21, which shall be funded by the General Fund.

17 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
18 Nation chairperson or any designated official is authorized to administer  
19 and expend the FY 2019 Executive Branch Tribal Budgets, provided that any  
20 amendments or modifications shall be submitted for prior approval by the  
21 Tohono O'odham Legislative Council.

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
23 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
26 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat.984).**




