

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Health and Human Services Self-Governance Budgets)**

**RESOLUTION NO. 18-340**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2019 Self-Governance Base Budgets and Savings  
9 Budgets for the period beginning October 1, 2018 and ending on September 30,  
10 2019 (collectively, "FY 2019 Department of Health and Human Services Self-  
11 Governance Budgets"), which are provided below and incorporated by this  
12 reference, in the total amount of \$7,863,118.00 to be funded by the Self-  
13 Governance Funding Agreement; and

14 **WHEREAS,** the following base budgets totaling \$5,794,253.00 have been prepared:

30 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
31 reviewed the FY 2019 Department of Health and Human Services Self-Governance  
32 Budgets and recommend their approval.

33 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
34 FY 2019 Department of Health and Human Services Self-Governance Budgets  
35 effective October 1, 2018 in the total amount of \$7,863,118.00 which shall be  
36 funded by the Self-Governance Funding Agreement.



1 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
2 O'odham Nation chairperson or any designated official is authorized to negotiate  
3 and execute amendments to the Self-Governance Funding Agreement with the  
4 IHS for the maximum allowable funding.


5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
6 Nation chairperson or any designated official is authorized to administer and  
7 expend the FY 2019 Department of Health and Human Services Self-Governance  
8 Budgets, provided that any amendments or modifications shall be submitted for  
9 prior approval by the Tohono O'odham Legislative Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>  
11 day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
13 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
14 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat.984).


