

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of September 2018)**

RESOLUTION NO. 18-351

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received written**
7 **statements from 06 tribal members who have expressed their intent to relinquish**
8 **their membership with the Tohono O'odham Nation and the members are**
9 **identified in the September 2018 Relinquishment List, which is incorporated by**
10 **this reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**
12 **A member of the Nation may relinquish his membership in the Nation by**
13 **submitting a written statement clearly expressing an intent to relinquish his**
14 **membership to the Council, a copy of which must be served on the**
15 **committee. The written statement must be signed by the person wishing to**
16 **relinquish his membership or, if a minor or incompetent, by the parent(s),**
17 **guardian or other person legally authorized to act on his behalf.**
18 **Relinquishment does not require the approval of the Council, but is effective**
19 **upon receipt of the statement by the Council and cannot be subsequently**
20 **denied. Upon recognition by the Council that the individual has renounced**
21 **his membership, his name shall be deleted from the membership roll.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
23 **recognizes that the individuals identified in the September 2018 Relinquishment**
24 **List have relinquished their membership in the Tohono O'odham Nation and**
25 **orders the removal of their names from the Nation's membership roll.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
27 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
28 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**


