

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Veterans Affairs Office Donations and Contributions Budget)**

RESOLUTION NO. 18-359

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Veterans Affairs Office has prepared and submitted for review and approval**
8 **its FY 2019 Donations and Contributions Budget, which is incorporated by this**
9 **reference, in the amount of \$67,883.58 to be funded from the FY 2018 Veterans**
10 **Affairs Office Donations and Contributions Budget carry over funds; and**

11 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
12 **reviewed the FY 2019 Veterans Affairs Office Donations and Contributions Budget**
13 **and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2019 Veterans Affairs Office Donations and Contributions Budget effective**
16 **October 1, 2018, in the amount of \$67,883.58, which shall be funded FY 2018**
17 **Veterans Affairs Office Donations and Contributions Budget carry over funds.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2019 Veterans Affairs Office Donations and Contributions Budget,**
21 **provided however, that any amendments or modifications shall be submitted for**
22 **prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
24 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
25 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**




