

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 General Support Services Accounting Budget Amendment No. 1)**

**RESOLUTION NO. 18-360**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1 (d)(2)); and**

7 **WHEREAS, the FY 2018 General Support Services ("GSS") Accounting Budget in the amount of**  
8 **\$5,030,031.00 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the GSS has prepared and submitted for review and approval its FY 2018**  
10 **Accounting Budget Amendment No. 1, which is incorporated by this reference**  
11 **and which will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2018 GSS Accounting Budget Amendment No. 1 will not change the total**  
13 **budget amount; and**

14 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2018 GSS Accounting**  
15 **Budget Amendment No. 1 and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approve the**  
17 **FY 2018 GSS Accounting Budget Amendment No. 1 effective October 1, 2017, which**  
18 **will not change the total budget amount of \$5,030,031.00.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation chairperson or any designated official is authorized to administer and**  
21 **expend the FY 2018 GSS Accounting Budget as amended, provided however, that**  
22 **any amendments or modifications shall be submitted to the Tohono O'odham**  
23 **Legislative Council for prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
25 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,867.15 FOR;**  
26 **217.45 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
27 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
30 **Act of June 18, 1934 (48 Stat.984).**


