

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Gu Achi District Mining Royalties Budget)**

**RESOLUTION NO. 18-364**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by a**  
6 **treasurer or other authorized officer of the district council who has furnished**  
7 **a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and**  
8 **all expenditures of these funds shall be by checks signed by such treasurer or**  
9 **other authorized officer and the chairman or vice chairman of the district**  
10 **council.**

12 **WHEREAS,** by Gu Achi District Council Resolution No. 0818-127, the Gu Achi District has  
13 **authorized and submitted for review and approval the FY 2019 Gu Achi District**  
14 **Mining Royalties Budget, which is incorporated by this reference, in the amount**  
15 **of \$111,948.13; and**

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Gu Achi District  
17 **Mining Royalties Budget and recommends its approval.**


18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
19 **FY 2019 Gu Achi District Mining Royalties Budget in the amount of \$111,948.13.**

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Gu Achi  
21 **District Mining Royalties Budget shall be managed and expended in accordance**  
22 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**  
23 **the Nation's laws, provided that any amendments or modifications shall be**  
24 **authorized under District Council resolution and submitted for prior approval by**  
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
27 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


