

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Continuing Resolution for San Lucy District)

RESOLUTION NO. 18-369

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3
4 **No district council shall expend district funds except pursuant to budgets**
5 **authorized under resolutions of the district council and approved by the**
6 **Tohono O'odham Council. The management of these funds shall be only**
7 **by a treasurer or other authorized officer of the district council who has**
8 **furnished a surety bond satisfactory to the treasurer of the Tohono**
9 **O'odham Nation, and all expenditures of these funds shall be by checks**
10 **signed by such treasurer or other authorized officer and the chairman or**
11 **vice chairman of the district council.; and**

13 **WHEREAS, the current fiscal year will expire on September 30, 2018 and the San Lucy**
14 **District's authority to expend funds appropriated for fiscal year 2018 will end on**
15 **this day; and**

16 **WHEREAS, by Resolution No. SL 08-162-18, the San Lucy District has requested approval of a**
17 **continuing resolution authorizing expenditures under the District's current**
18 **budget beyond the end of this fiscal year and until a FY 2019 budget is approved**
19 **by Legislative Council; and**


20 **WHEREAS, there are sufficient funds in the San Lucy District account to continue District**
21 **operations.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes**
23 **the San Lucy District to expend funds in accordance with the District's FY 2018**
24 **Budget after September 30, 2018 and until a FY 2019 San Lucy District Budget is**
25 **approved by Legislative Council resolution.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
27 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,848.8 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and 235.8[02] ABSENT, pursuant to the powers vested in the**
29 **Council by Article IX, Section 7 and Article VI, Section 1(d)(2) of the Constitution of the Tohono**
30 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**
31 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
32 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


