

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Natural Resources Cultural Affairs Tribal
Historic Preservation Office Budget)**

RESOLUTION NO. 18-377

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the United States Department of the Interior National Park Service has awarded**
8 **the Department of Natural Resources Cultural Affairs Tribal Historic**
9 **Preservation Office a grant in the amount of \$90,041.00; and**

10 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
11 **approval its FY 2019 Department of Natural Resources Cultural Affairs Tribal**
12 **Historic Preservation Office Budget, which is incorporated by this reference, in**
13 **the amount of \$90,041.00 to be funded by the Nation's general fund pending**
14 **reimbursement from the grantor; and**

15 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
16 **FY 2019 Department of Natural Resources Cultural Affairs Tribal Historic**
17 **Preservation Office Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2019 Department of Natural Resources Cultural Affairs Tribal Historic**
20 **Preservation Office Budget effective October 1, 2018 in the amount of \$90,041.00,**
21 **which shall be funded by the Nation's general fund pending reimbursement from**
22 **the grantor.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Natural Resources Cultural Affairs Tribal**
26 **Historic Preservation Office Budget, provided that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
30 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
