

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Sif-Oidak District Carryover Budget Using FY 2016/2017
Gaming Revenue Carryover Funds)**

RESOLUTION NO. 18-380

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 18-146 the Sif-Oidak District
13 **has authorized the Sif-Oidak District Carryover Budget for FY 2019, which is**
14 **incorporated by this reference, in the amount of \$411,973.31 which shall be**
15 **funded by FY 2016/2017 gaming revenue carryover funds; and**

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Sif-Oidak District
17 **Carryover Budget and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2019 Sif-Oidak District Carryover Budget in the amount of \$411,973.31 which**
20 **shall be funded by FY 2016/2017 gaming revenue carryover funds.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Sif-Oidak**
22 **District Carryover Budget shall be managed and expended in accordance with**
23 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
24 **Nation's laws, provided that any amendments or modifications shall be**
25 **authorized under District Council resolution and submitted for prior approval by**
26 **the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
28 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,858.7 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and 225.9 [05] ABSENT, pursuant to the powers vested in the**
30 **Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
