

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Baboquivari District Budgets)**

RESOLUTION NO. 18-381

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Baboquivari District Council Resolution No. 2018-B-66, the Baboquivari
13 District has authorized the expenditure of funds for the FY 2019 Baboquivari
14 District Budgets, which are incorporated by this reference, in the amount of
15 \$3,955,217.99; and

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Baboquivari District
17 Budgets and recommends approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2019 Baboquivari District Budgets in the amount of \$3,955,217.99, which
20 includes funding from:

- 21 1. FY 2019 Baboquivari District Gaming Allocation in the amount of
22 \$3,273,977.01;
- 23 2. FY 2018 carry forward funds in the amount of \$326,219.72;
- 24 3. FY 2013 carry forward funds in the amount of \$62,557.17;
- 25 4. FY 2019 Asarco Mining Royalties in the amount of \$212,640.62;
- 26 5. FY 2019 Cyprus Mining Royalties in the amount of \$63,970.36; and
- 27 6. Office of Special Trustee funds in the amount of \$15,853.11.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019
29 Baboquivari District Budgets shall be managed and expended in accordance with
30 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
31 Nation's laws, provided that any amendments or modifications shall be
32 authorized under District Council resolution and submitted for prior approval by
33 the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,858.7 FOR; -0- AGAINST; -0- NOT VOTING; and 225.9 [05] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
