

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Sells District Administration and Community Budgets)**

**RESOLUTION NO. 18-382**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** by Sells District Council Resolution No. SD-69-18 the Sells District has authorized  
13 the FY 2019 Sells District Administration and Community Budgets, which is  
14 incorporated by this reference, in the amount of \$3,273,977.01; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Sells District  
16 Administration and Community Budgets and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18 FY 2019 Sells District Administration and Community Budgets in the amount of  
19 \$3,273,977.01.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Sells  
21 District Administration and Community Budgets shall be managed and expended  
22 in accordance with Article IX, Section 7 of the Constitution of the Tohono  
23 O'odham Nation and the Nation's laws, provided that any amendments or  
24 modifications shall be authorized under District Council resolution and  
25 submitted for prior approval by the Tohono O'odham Legislative Council.

26 **The foregoing Resolution** was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>  
27 day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,858.7 FOR;  
28 -0- AGAINST; [01] NOT VOTING; and 225.9 [06] ABSENT, pursuant to the powers vested in the  
29 Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by  
30 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
31 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
32 18, 1934 (48 Stat.984).
