

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Gu-Vo District Budget)

RESOLUTION NO. 18-386

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Gu-Vo District Resolution No. GV-18-069, the Gu-Vo District has authorized the
13 FY 2019 Gu-Vo District Budget, which is incorporated by this reference, in the
14 amount of \$3,273,977.13; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Gu-Vo District
16 Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2019 Gu-Vo District Budget in the amount of \$3,273,977.13.

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Gu-Vo
20 District Budget shall be managed and expended in accordance with Article IX,
21 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,
22 provided that any amendments or modifications shall be authorized under
23 District Council resolution and submitted for prior approval by the Tohono
24 O'odham Legislative Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST
26 day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,649.7 FOR;
27 -0- AGAINST; -0- NOT VOTING; and 434.9 [07] ABSENT, pursuant to the powers vested in the
28 Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by
29 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
31 18, 1934 (48 Stat.984).
