

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Pisinemo District Gaming Distribution Budget)**

RESOLUTION NO. 18-387

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** by Pisinemo District Council Resolution No. 18-P-26 the Pisinemo District has
13 **authorized the FY 2019 Pisinemo District Gaming Distribution Budget, which is**
14 **incorporated by this reference, in the amount of \$3,273,977.01; and**

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Pisinemo District
16 **Gaming Distribution Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2019 Pisinemo District Gaming Distribution Budget in the amount of**
19 **\$3,273,977.01.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Pisinemo**
21 **District Gaming Distribution Budget shall be managed and expended in**
22 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
23 **Nation and the Nation's laws, provided that any amendments or modifications**
24 **shall be authorized under District Council resolution and submitted for prior**
25 **approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
27 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,649.7 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and 434.9 [07] ABSENT, pursuant to the powers vested in the**
29 **Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**




