

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Chukut Kuk District Budget)**

RESOLUTION NO. 18-390

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **"No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council."**

12 **WHEREAS, by Chukut Kuk District Resolution No. 2018-40 the Chukut Kuk District has**
13 **authorized the FY 2019 Chukut Kuk District Budget, which is incorporated by this**
14 **reference, in the amount of \$2,017,635.31, with the remaining balance of**
15 **\$1,256,341.70 to be budgeted at a later date; and**

16 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Chukut Kuk District**
17 **Budget and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2019 Chukut Kuk District Budget in the amount of \$2,017,635.31, which shall**
20 **be funded by the FY 2019 Chukut Kuk District Gaming Allocation funds.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Chukut**
22 **Kuk District Budget shall be managed and expended in accordance with Article**
23 **IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's**
24 **laws, provided that any amendments or modifications shall be authorized under**
25 **District Council resolution and submitted for prior approval by the Tohono**
26 **O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
28 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,649.7 FOR;**
29 **~~0~~ AGAINST; [01] NOT VOTING; and 434.9 [06] ABSENT, pursuant to the powers vested in the**
30 **Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
