

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2019 San Xavier District Budget)**

RESOLUTION NO. 18-391

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, by San Xavier District Council Resolution No. SXDC 08-18-06, the San Xavier**
13 **District has authorized the FY 2019 San Xavier District Budget, which is**
14 **incorporated by this reference, in the amount of \$13,331,452.00; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 San Xavier District**
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2019 San Xavier District Budget in the amount of \$13,331,452.00, which**
19 **includes funding from:**

- 20 **1. FY 2019 San Xavier District Gaming Allocation funds in the amount of**
21 **\$5,882,784.00;**
- 22 **2. ASARCO mining allocation in the amount of \$372,121.00;**
- 23 **3. Cyprus mining allocation in the amount of \$111,948.00;**
- 24 **4. ASARCO Mine lease rental-Office of Special Trustees in the amount of**
25 **\$7,806.00;**
- 26 **5. grant funds in the amount of \$510,790.00;**
- 27 **6. 9B Farm Cash Out funds in the amount of \$5,550,000.00;**
- 28 **7. Reserve Investment Account funds in the amount of \$510,000.00; and**
- 29 **8. Employee Benefit Trust Account in the amount of \$386,002.00.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 San**
31 **Xavier District Budget shall be managed and expended in accordance with Article**
32 **IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's**
33 **laws, provided that any amendments or modifications shall be authorized under**
34 **District Council resolution and submitted for prior approval by the Tohono**
35 **O'odham Legislative Council.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST
2 day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 1,585.45 FOR;
3 301.25 AGAINST; 763.0 [05] NOT VOTING; and 434.9 [07] ABSENT, pursuant to the powers vested in
4 the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted
5 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
6 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
7 Act of June 18, 1934 (48 Stat.984).
