

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Judicial Branch Budget Amendment No. 1)

RESOLUTION NO. 18-392

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Judicial Branch Budget in the amount of \$7,131,686.87 was approved**
8 **by Resolution No. 18-297; and**

9 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
10 **2019 Budget Amendment No. 1, which is incorporated by this reference and which**
11 **will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2019 Judicial Branch Budget Amendment No. 1 will increase the FY 2019**
13 **Judicial Branch Budget by \$40,635.00 from \$7,131,686.87 to \$7,172,321.87; and**


14 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2019**
15 **Judicial Branch Budget Amendment No. 1 and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Judicial Branch Budget Amendment No. 1 effective October 1, 2018, which**
18 **includes a \$40,635.00 increase from \$7,131,686.87 to \$7,172,321.87 that shall be**
19 **funded by the Nation's general fund.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge or any**
21 **designated official is authorized to administer and expend the FY 2019 Judicial**
22 **Branch Budget as amended, provided however, that any modifications or**
23 **amendments shall be submitted for prior approval by the Tohono O'odham**
24 **Legislative Council.**


25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
26 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,649.7 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and 434.9 [07] ABSENT, pursuant to the powers vested in the**
28 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**


