

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No.18-365 to Reflect Legal Name Changes
of Enrolled Members)**

RESOLUTION NO. 18-393

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 18-365 be**
17 **amended to reflect the amended names for the members identified in the**
18 **September, 2018 Amended Enrollment Resolution Summary, which is**
19 **incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **No. 18-365 are amended upon the effective date of those resolutions to reflect the**
22 **legal name changes for the members identified in the September, 2018 Amended**
23 **Enrollment Resolution Summary.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
25 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,649.7 FOR;**
26 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 434.9 [08] ABSENT, pursuant to the powers vested in the**
27 **Council by Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
28 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**
29 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
30 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
