

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Natural Resources USDA PRF Insurance
Program Budget Amendment No. 1)**

RESOLUTION NO. 18-396

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Natural Resources USDA PRF Insurance Program**
8 **Budget in the amount of \$7,017,074.00 was approved by Resolution No. 17-570;**
9 **and**

10 **WHEREAS, the Nation's Treasurer has identified for audit purposes that the USDA PRF**
11 **Insurance Program is based on a calendar year, January through December and**
12 **the Nation operates based of a fiscal year which is an accounting period, October**
13 **1 through September 30; and**

14 **WHEREAS, the approved FY 2018 budget amount of \$7,017,074.00 should be decreased to**
15 **\$5,264,408.25 to account for the USDA PRF Insurance program Premium**
16 **Allocation covering only a portion of the Nation's FY 2018 (January 1, 2018 through**
17 **September 30, 2018); and**

18 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
19 **approval its FY 2018 Department of Natural Resources USDA PRF Insurance**
20 **Program Budget Amendment No. 1, which is incorporated by this reference and**
21 **which adjusts operational line items; and**

22 **WHEREAS, the FY 2018 Department of Natural Resources USDA PRF Insurance Program**
23 **Budget Amendment No. 1 will decrease FY 2018 Department of Natural Resources**
24 **USDA PRF Insurance Program Budget by \$1,752,665.75 from \$7,017,074.00 to**
25 **\$5,264,408.25; and**

26 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
27 **have reviewed the FY 2018 Department of Natural Resources USDA PRF Insurance**
28 **Program Budget Amendment No. 1 and recommend its approval.**

29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
30 **FY 2018 Department of Natural Resources USDA PRF Insurance Program Budget**
31 **Amendment No. 1 which includes a \$1,752,665.75 decrease from \$7,017,074.00 to**
32 **\$5,264,408.25.**



3 expend the FY 2018 Department of Natural Resources USDA PRF Insurance
4 Program Budget as amended, provided that any amendments or modifications
5 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST
7 day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,122.5 FOR;
8 527.2 AGAINST; -0- NOT VOTING; and 434.9 [07] ABSENT, pursuant to the powers vested in the
9 Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,
10 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
11 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
12 Act of June 18, 1934 (48 Stat.984).


