14	WHEREAS,	pursuant to 26 Tohono O'odham Code Chapter 1 Article 4 - Contracting and
15		Procurement Authority, the Nation's Chairperson is the designated signatory and
16		official representative of the Nation on all contracts and agreements; and
17	WHEREAS,	the Domestic Affairs Committee have reviewed the Radio Use Agreement and
18		recommend its approval.
