

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Membership Services Enrollment Committee
Budget Amendment No. 2)**

RESOLUTION NO. 18-402

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2018 Department of Membership Services Enrollment Committee Budget
8 in the amount of \$46,210.32 was approved by Resolution No. 17-437 and
9 subsequently amended by Resolution No. 18-210; and

10 **WHEREAS,** the Department of Membership Services has prepared and submitted for review
11 and approval its FY 2018 Enrollment Committee Budget Amendment No. 2, which
12 is incorporated by this reference and which will adjust operational and/or
13 personnel line items; and

14 **WHEREAS,** the FY 2018 Department of Membership Services Enrollment Committee Budget
15 Amendment No. 2 will increase the FY 2018 Enrollment Committee Budget by
16 \$7,242.82 from \$46,210.32 to \$53,453.14; and

17 **WHEREAS,** the Rules and Budget and Finance Committees have reviewed the FY 2018
18 Department of Membership Services Enrollment Committee Budget Amendment
19 No. 2 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2018 Department of Membership Services Enrollment Committee Budget
22 Amendment No. 2, which includes a \$7,242.82 increase from \$46,210.32 to
23 \$53,453.14 that shall be funded by the Nation's general fund surplus.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2018 Department of Membership Services Enrollment Committee
27 Budget as amended, provided that any amendments or modifications shall be
28 submitted for prior approval by the Tohono O'odham Legislative Council.

29 **The foregoing Resolution** was passed by the Tohono O'odham Legislative Council on the 26TH
30 day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;
31 -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by
32 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
33 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
34 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
35 18, 1934 (48 Stat.984).
