

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Contract between Belfor Property Restoration and the Tohono O'odham
Nation and Approving FY 2019 Department of Health and Human Services
Division of Child Welfare Building Budget)

RESOLUTION NO. 18-403

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Constitution of the Tohono O'odham Nation also vests the Legislative Council
8 with the authority to "consult, negotiate and conclude agreements and contracts
9 on behalf of the Tohono O'odham Nation with Federal, State and local
10 governments and other Indian tribes or their departments, agencies, or political
11 subdivisions, or with private persons or organizations on all matters within the
12 authority of the Tohono O'odham Council" (Constitution, Article VI, Section 1(f));
13 and

14 **WHEREAS,** the Nation has entered into a contract, which is incorporated by this reference,
15 with Belfor Property Restoration for restoration services for the Department of
16 Health and Human Services Child Welfare building pursuant to an insurance
17 claim filed by the Nation; and

18 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
19 review and approval its FY 2019 Division of Child Welfare Building Budget, which
20 is incorporated by this reference in the amount of \$668,922.81, of which
21 \$205,502.66 will be a one-time tribal supplemental funding request and
22 \$463,420.15 will be from insurance claim proceeds for restoration of the Child
23 Welfare building; and

24 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
25 reviewed the contract between the Nation and Belfor Property Restoration and
26 the FY 2019 Department of Health and Human Services Division of Child Welfare
27 Building Budget and recommend its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council ratifies
29 approval of the contract between the Nation and Belfor Property Restoration as
30 of June 5, 2018 and approves the FY 2019 Department of Health and Human
31 Services Division of Child Welfare Building Budget, effective October 1, 2018 in
32 the amount of \$668,922.81, of which \$205,502.66 shall be funded by the Nation's

general fund surplus as one-time funding and \$463,420.15 shall be funded by insurance claim proceeds.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2019 Department of Health and Human Services Division of Child Welfare Building Budget, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.


The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


